How is a foreign exchange payment processed in Morocco?

According to regulations governing foreign exchange, payment of goods imported into Morocco is processed only after the actual entrance of the goods into the country. Buyers are allowed to prepay up to 30 percent of the invoice amount for all goods.

How do I pay for imports in Morocco?

To pay for imports of goods and services into Morocco, local importers do not need an authorization from the Foreign Exchange Office (Office des Changes).

How does a Moroccan bank ensure full prepayment?

It is also possible for the Moroccan bank to ensure full prepayment upon receipt of a document showing that the merchandise is in transit. Banks are authorized to issue bank guarantees to secure payments to foreign suppliers. Importers normally give local buyers up to 90 days credit.
