Who owns a container terminal?

Port authorities have jurisdiction over most U.S. container terminals, although some container terminals are owned or leased by private interests. Private bulk terminals are normally outside public port authority jurisdiction although they are still subject to U.S. Coast Guard and Federal regulation.
